Resolution 2020-35: Resolution for Local Disaster Declaration (see attached)

Tyree presented Resolution 2020-35: Resolution for Local Disaster Declaration and explained that the state recommends that all counties declare a local disaster emergency. This helps Moffat County be eligible for funding sources from state and federal government. Tyree read the resolution into the record. The Colorado Department of Emergency Field Manager, Drew Petersen, recommends that this declaration stay in place at least six months.

Cook made a motion to approve Resolution 2020-35: Resolution for Local Disaster Declaration. Broom seconded the motion. Motion carried 3-0

There was also some discussion about next steps for Moffat County regarding COVID-19, specifically a Stay at Home or Shelter in Place order. Dr. Harrington recommended being pro-active rather than reactive. Olivia Scheele said that if Moffat County went with an order, it would help "flatten" the curve for incubation times. Sheriff Hume feels like Dr. Harrington was just advising that Moffat County be ready (document-wise) for such orders. Kari Ladrow advised that we look at "trigger points" and start getting our plan in place in advance, before we have any diagnosed cases.
