### Vickie Huyser:

Asked the BOCC what they know about the deal between the Hospital, the School Board and Providence Recovery regarding the Yampa Building for use as a drug rehab center. Cook said the County and the City have not been part of that discussion, because the School District/Board is an independent entity.

Huyser also asked if County Public Health could deal with a condemned building where drug addicts are living with no water, sewer or trash. Cook suggested because it is in the City, it is probably their responsibility.

# Jayne Morley:

Questioned the BOCC when they knew about the deal for the rehab center and how they felt about it. Feels that it was done in much too quiet of a way; too much conflicting information coming out; the students are getting the short end of the stick by charging such a low dollar amount for the building.

### Ken Wergin:

Supports the drug rehab program. Has been doing a lot of mowing around town. Commended the local governments on all the clean-up and projects that are going on right now. Beck complimented Wergin on his community service.

# John Anderson, VP/CNCC:
