#### **Finance Department – Mindy Curtis**

#### **Department of Human Services - Dollie Rose**

Rose stated there are 6 certified foster homes and one in the process.

This Friday July 27 from 9-10:30 am there will be a CDHS Summer Planning tour, to be held at CNCC.

Rose presented the Electronic transactions for the month of April. Rose noted that the Child Welfare is \$71,000; of this congregate care cost is over \$62,000. There were 13 placements total for the month of March.

Cook made a motion to approve the Electronic Transactions for April \$297,011.76 and May \$320,607.65 Moe seconded the motion. Motion carried 3-0.

Rose discussed the Out of Home Placements. Rose stated the kids that have been ordered into home placement have been placed outside of Moffat County.

#### **Introduction:**

Beck introduced Marci Marumoto. Marumoto stated KRAI was recently purchased by Steamboat Radio.

#### Office of Developmental Services - Roy Tipton

Tipton presented a bid recommendation for rooftop unit replacement at Department of Human Services. Tipton stated they received only one bid from Master Works Mechanical.

Cook made a motion to approve the bid to Master Works Mechanical for \$21,000 for the replacement of a rooftop unit. Moe seconded the motion. Motion carried 3-0.

#### Sheriff's Office - KC Hume

Hume gave an update on the wildland fire conditions. Hume stated the fire conditions have not improved, nor does he feel that conditions will improve for some time. There are two fires currently burning in this area; the Indian Valley Fire in Moffat/Rio Blanco Counties and the Sulfur Fire in Rio Blanco County. Hume stated both Moffat and Rio Blanco Counties will remain in Stage 1 Fire Restriction.
