Cook added that the BLM needs to comply with the necessary steps that any other agency would need to go through.

- ✓ The Northwest Colorado Transportation TPR meeting where they discussed two statewide ballot measures. The sales tax measure makes the most sense from Club 20's perspective
- ✓ The Western Region CCI meeting in Montrose on policy & ballot questions
- ✓ Representing AGNC at the dedication ceremony for the Cameo Shooting Complex
- ✓ The Colorado Aeronautical board meeting

- ✓ The Yampa River Legacy meeting
- ✓ A special BOCC meeting on Thursday, September 6, 2018 to discuss the ballot measure that is due to the Clerk's office on September 7, 2018

- ✓ The BOCC commended the Craig Rural Fire Department for the efficiency of the work done on all of the fires over the weekend

Natural Resources Department - Jeff Comstock & County Attorney - Rebecca Tyree

- ✓ Comstock & Tyree discussed joining the PILT Class Action Lawsuit
 - o Comstock is asking the BOCC to join the class action lawsuit. Congress has not been funding the full amount to PILT (payment in lieu of taxes). Federal agencies make these payments because they are not required to pay property taxes. This affects every county in the country with federal lands. Kane County, Utah won its lawsuit regarding the same matter, and it was decided then that this should be a class action lawsuit.
 - o This will yield about \$27,000, and the County will retain over \$18,000 after fees. Winning this lawsuit is highly likely according to Comstock & Tyree.
 - o Tyree recommends that the BOCC opt in to this lawsuit.
- ✓ Tyree & Comstock presented Resolution 2018-95: Resolution to opt-in to PILT Payments Class Action Lawsuit and Authorization for Moffat County Attorney to act as Point of Contact for the Moffat County Board of County Commissioners.
