# Weed & Pest Management - Jesse Schroeder

Present comment letter to Department of the Interior regarding Invasive Species management plan (see attached)

Schroeder brought a comment letter from the BOCC to the Department of the Interior, regarding a new Invasive Species strategic management plan. The DOI plan did not specifically mention any local input, which is something that Moffat County would definitely like to change, to be part of the decision making process.

Personnel Requisition for Office of Emergency Management Coordinator (see attached)

They are looking at making this a full time position; it is a statutorily required position, and is funded at 50% by the State. The goal is to have someone in place ASAP.

Norton presented a resolution Amending Purchasing Policy and Procedures of Moffat County Allowing for Director of Moffat County Department of Human Services to Sign Child Care Provider Services Contracts after review by the County Attorney, up to \$25,000 or less.
