Finance Department- Mindy Curtis

Curtis reviewed the DOLA grant agreement for the Fiscal Health Initiative. The project consists of Moffat County engaging with a consultant to develop a cost analysis model to support the County's shift to priority based budgeting.

Priority based budgeting is based on services. A web based system allows the County to gather data and costs of services. The total cost of the project is \$39,000 with the grant being in the amount of \$19,500.00.

Moffat County Broadband Planning- Audrey Danner

Danner gave an update on the Broadband planning project and reviewed survey results.

2016 surveys were completed over several weeks. Concerns expressed in survey include: reliability, dissatisfaction in current internet speed, pricing, increasing demands on connectivity, businesses identified broadband as critical, and most of us view broadband as a utility and essential service.

Danner indicated the importance of Broadband to strengthen our community. Local government must promote and enhance this infrastructure.

CCI will work with the legislature this year to consider bills that would form Local Improvement Districts, repeal 05-152 (Moffat County has opted out, but many jurisdictions have not) and "perfection of easements".
