Cook made a motion to approve the agenda as presented. Moe seconded the motion. Motion carried 2-0.

Cook made a motion to approve the consent agenda consisting of:

Human Resources- Lynnette Siedschlaw Sheriff's Department- Charlene Abdella Social Services- Dollie Rose

Siedschlaw reviewed personnel requisitions for the Sheriff's Department Master Control Operator and for a Case Services Aide at Social Services. Both positions are vacant due to terminations within the departments.

Cook made a motion to approve the personnel requisition for a part-time Master Control Operator at the Sheriff's Department. Moe seconded the motion. Motion carried 2-0. See attached.

Cook made a motion to approve the personnel requisition for a full-time Case Services Aid at Social Services. Moe seconded the motion. Motion carried 2-0. See attached.

#### Museum of Northwest Colorado- Dan Davidson

Davidson reviewed the storage building lease. This is a six month lease for storage of museum artifacts. The total lease amount is \$3,000.

Cook made a motion to approve the storage building lease with Coldwell Banker's- Inness for the Museum of Northwest Colorado, with the correction to change the lease to semi-annual under paragraph number 4. Moe seconded the motion. Motion carried 2-0. See attached.

#### **Presentations:**

#### Memorial Hospital- Andy Daniels & Todd Jourgensen

Daniels reported the Hospital Board re-elected their new officers and Committee members. Todd Jourgensen is the new Chairman, Catherine Blevins, Vice-Chair, and Alman Nicodemus is the Secretary/Treasurer. See attached.

Daniels discussed the Hospitals intent to refinance the Hospital loan with HUD Bonds. The refinance would save the Hospital approximately \$100,000 per month. Mortgage reserves will be returned to the hospital. The new loan will also restructure the lease agreement between the County and the Memorial Hospital Facilities Corporation.

Daniels reviewed the resolution and lease documents:

- 1. A resolution to terminate the site lease between Moffat County and the Facilities Corporation.
- 2. Site lease between Moffat County and the Memorial Hospital Board of Trustees.
- 3. Mutual release of 2008 site lease and operating agreement.

The term of the new loan is thirty five years.

Moe thanked Becky Tyree and Mindy Curtis for their assistance to help expedite this process.

Cook also thanked Catherine Blevins and Denise Arola for their work and indicated they were instrumental in this process.

The Facilities Corp will have no further reason to exist after the refinance and will not be meeting again.

A special meeting will be held tomorrow morning at 9:00 am in order to approve these resolutions and documents.

Daniels also reported the Memorial Hospital has been approved by the Colorado Department of Health and Environment as a "Health Professional Shortage Site". They are now eligible to apply for Rural Health Care and will participate in the survey. Hospitals are currently being taxed a provider fee for federal matching dollars. Those funds are redistributed by the State. As this is part of the General Fund, the Governor has decided to reduce the provider fees, in order to offset the budget. This will be detrimental to some hospitals as they will experience extreme losses.
