## Road & Bridge Department- Dan Miller

#### Social Services- Dollie Rose

Rose reviewed the Community Services Block Grant program and requested the Commissioners sign a letter to discontinue administration of this program. The program has become burdensome and expensive to the Social Services Department; however it is a good program for the community. DOLA will release an RFT to find a suitable provider in the community. United Way has expressed interest in the management of this program.

Beck made a motion to sign a letter to discontinue the Community Services Block Grant Program. Cook seconded the motion. Motion carried 3-0. See attached.

Rose reviewed the proposal for Colorado Community Response program. The Department will apply for funding in order to implement this new program. In 2013 Governor Hickenlooper introduced the Enhanced Welfare Program. Social Services will now be able to work with families in crisis and provide assistance. The grant application is in the amount of \$150,000, and is 100% funded. The program will be evaluated every year and is eligible for renewal for four years.

Cook made a motion to approve the State of Colorado Department of Human Services request for proposal IHIA 2017000228 for The Colorado Community Response program. Beck seconded the motion. Motion carried 3-0 See attached.

### **Human Resources- Lynnette Siedschlaw**

Siedschlaw reviewed personnel requisitions for the Fairgrounds and Cemetery seasonal help, Pest Management seasonal workers and for the Sheriff's Office administrative assistant.

The seasonal workers are all hired through Flint Personnel. The two employees for the Fairgrounds and Cemetery will start this month and work for six months.

Beck made a motion to approve the personnel requisition for two part-time seasonal workers for the Fairgrounds and Cemetery. Cook seconded the motion. Motion carried 3-0. See attached.

The seven employees for the Weed Program will work throughout the summer. Most of these positions are returning college students. Their duties include mosquito control, weed and rodent control and other pest abatements.

Cook made a motion to approve the personnel requisition for seven part-time seasonal workers for the Weed and Pest Management Department. Beck seconded the motion. Motion carried 3-0. See attached.

The Sheriff has a vacancy for an administrative position. This is a full-time, existing position and will be eligible for rehire April 24th.

Beck made a motion to approve the personnel requisition for a full-time administrative assistant at the Sheriff's Department. Cook seconded the motion. Motion carried 3-0. See attached.
