 - DOLA asked that the Broadband Committee hire a project manager and network operator to do the final engineering, get solid construction costs, and have a strong plan in place before applying for a grant for construction funds.
 - The committee is starting the bid process for the project, and the winning bid will be included in the grant submitted to DOLA on April 1, 2018.
 - There is a need for funding to help match the bid. That number will be more concrete after the bidding process is complete, but Balleck believes the match

will be around \$100,000. The RFPs have been given to both the County and City Attorney's for review.
