The BOCC discussed a letter of interest (see attached) for an open seat on 14th Judicial District Community
Corrections Board submitted by John Ponikvar. Ponikvar had previously served on this board and had been
asked to reapply.

Broom made a motion to approve appointing John Ponikvar to the open seat on the 14th Judicial District Community Corrections Board. Beck seconded the motion. Motion carried 3-0.

Staff Reports:

Natural Resources Department - Jeff Comstock & Brown's Park Alumni Association - Kathy Bower

Comstock presented a Memo of Understanding (see attached) between Moffat County and the Brown's Park Alumni Association regarding ownership of the Brown's Park School building. Moffat County acquired the building on behalf of the Alumni Association from the Moffat County School District. At that time, the School District also included \$25,000, which was what they had budgeted to tear the building down; that money was put in an account for the Alumni Association, and used for maintenance and upkeep of the building. Currently, the BLM owns the land under the school building. Bruce Sillitoe, the present LSR Office Director, wants to clean this up, and as soon as a clear deed is acquired by the County, they will transfer it to the Alumni Association. The Association has done several preservation projects on the building and it is used as a Community Center/Museum, and hosts several events during the year. Comstock will bring a document to the next BOCC meeting to contract with the BLM for the land appraisal process. The BLM has ordered this appraisal, but that could take up to a year; the cost of the appraisal is expected to be less than \$10,000. They are expecting the value of the land to be less than \$2000. Commissioner Broom commented that not only was it great that they would be preserving history, but that they would be taking the property out from under the government.

Beck made a motion to approve signing the Memo of Understanding with the Brown's Park Alumni Association. Broom seconded the motion. Motion carried 3-0

Office of Development Services - Roy Tipton

Tipton presented Resolution 2109-39: Authorization to Sell County Property at 1374 Sequoia Ave by Public Auction (see attached). This property was acquired by the County through a Treasurer's Office tax sale. The assessed value of the property is \$23,000; when the property goes to auction in May, we will probably set the minimum value at \$15,000. The County needs to recover \$9800 for our costs.
