- ✓ Colorado Initiatives that will be on the November ballot that Club 20 took a position on: Initiative 173 Stop Buying Our Elections; 167 Fix the Roads; 97 Oil & Gas Set-Back Regulation & 108 Property Owner Compensation
- ✓ Public discussion was held about the wild horses in Sand Wash Basin, with members from the Wild Horse Warriors. They brought several handouts with data and more information. Staff Reports:

Road & Bridge Department – Dan Miller

Miller presented the bids for the 2018 Striping Project and he recommended the bid from Stripe A Lot, Inc. out of Montrose for \$22,595 because it is the lower of the two bids. Miller also mentioned that this does not meet the budget so more striping may be done than originally anticipated.

Office of Development Services - Roy Tipton

Tipton presented the bids for (3) Roof-Top Units at the Public Safety Center. The units are 18 years old, and are in the Capital Improvement Plan. Tipton recommended the low bid from Masterworks Mechanical for \$21,800.

Burns presented the "On Common Ground" publication. It contains information about the National Association of Realtors and Fair Housing Act's 50 year anniversary. Burns hoped that
